6. It will continue to pay an Annual Fee of **Rs. 3000/- p.a.** The schools run by KV/ KVS/ NVS/ Army/Navy/Air Force/Military/ Govt./Govt. Aided/Sainik/Railway/Atomic Energy etc. are granted regular affiliation and these schools have been advised to remit prescribed annual fee by D.D. in favour of **Secretary, CBSE, payable at Delhi.** This may be complied in future.
7. **Annual fee has been received upto 31/03/2018.**
8. **The school is required to submit the latest copy of certificate regarding availability of Health & Sanitation of the school issued by Competent Authority of the State.**
