6. It will continue to pay an Annual Fee of Rs. 3000/- p.a. The schools run by KV/ KVS/ NVS/ Army/Navy/Air Force/Military/ Govt./Govt. Aided/Sainik/Railway/Atomic Energy etc. are granted regular affiliation and these schools have been advised to remit prescribed annual fee by D.D. in favour of Secretary, CBSE, payable at Delhi. This may be complied in future.
